Chapter Members Will Hear a New Organ at November Meeting

n November, STLAGO members will join Trinity Episcopal Church for the dedicatory concert on its new pipe pipe organ. Quimby Pipe Organs, Inc., of Warrensburg, Mo., has built a beautiful instrument of two manuals and 23 ranks. This instrument has a wonderful array of diapasons, flutes, strings, and several distinctive and highly colorful reed stops. The instrument's action is electro-pneumatic with slider chests based on the Blackinton design, which allows pipes to speak very clearly and practically instanta-

class organist and "hometown boy who has made good," St. Louisan Zach Hemenway.

Zach began playing the organ at St. Simon the Apostle Church in south St. Louis County. He studied organ with our own Dr. Marie Kremer. Advent = Rodney Dangerfield?

s far as *The Opus* goes, we're about to go 'round the dark side of the moon and you won't hear from us again until January. We don't do a December newsletter, figuring you're all way too busy to read it!

I'll give thanks for all of you this Thanksgiving — the work you do, the support you provide, the talent you share. I enjoy Thanksgiving. It's generally unencumbered by a lot of work issues, except there is that nagging foreboding, that voice that's whispering "Advent..."

Increasingly our culture and our places of worship want to rush over (or skip entirely) any thought of penitential preparation. I really treasure this period in worship; it seems like a moment frozen in amber, a suspen-

Wrongful Termination? What's the Next Step?

So...I have been "wrongfully terminated" from my church job. Can the AGO help?

Step One – The Preliminary Evaluation

Yes the AGO can help – not to get your job back – but to offer a healing process that might lead to your termination being in good standing – which is important in securing a new job. **First, though, you have to help yourself**. The guild is not a union. We do not have laws, etc., only procedures to help you get through such situations. First step is:

1. Contact the Chapter Dean **in writing** with a copy sent to our Regional Councilor (call to get address). In this letter, outline your work history at the institution and fully explain your claim of wrongful termination. It is important to include employment documentation, e.g., letter of agreement, employee manual, termination notice, contracts and all other signed documents in connection with the employment. A **"paper trail" is essential**. Copies of all correspondence, e-mails, faxes, summaries of phone calls, and documentary evidence should be archived indefinitely. Be willing to cooperate fully, in a timely manner, and be honest in you conversations. Hearsay is not considered evidence.

2. Next the Chapter Dean (or other chapter officer) will send the request along with documentation to the Chapter Coordinator for Professional Development, Regional Councilor, Regional Coordinator for Professional Development and the National Councilor for Professional Development. These people will meet (via phone conference) to decide if your complaint will be acted upon.

If it is determined that your complaint deserves further consideration, a local committee will be appointed in consultation with the Regional Councilor. More next time.

The protagonist is walking through a garden with the Holy Spirit. Inwardly he's thinking that it's a total mess, but there's something oddly familiar about it. He mentions this, and the Holy Spirit replies: "...This garden is your soul — this mess is you...And it's wild and beautiful and perfectly in process. To you, it seems messy, but to me, I see a perfect pattern emerging and growing and alive — a living fractal."

So...may we learn to respect Advent a little more — and may your December be one big, beautiful mess. — *Chuck Peery*




